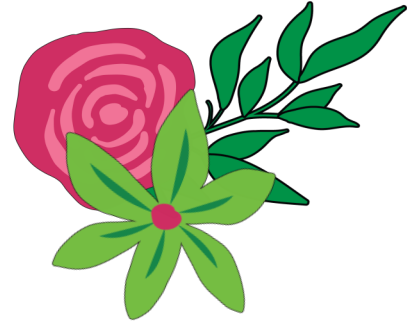


Celebrate Spring

A six-foot table will be provided for each vendor and placed at a socially-distanced space outdoors. Swap/Sell participants will be in a designated area. Vendors will manage their own monetary transactions and may swap and/or sell, at the discretion of the participant.

- Please attach a card with plant identification and water/light requirements
- Participants must handle all monetary transactions
- All items must be removed from the premises by 6:00 pm
